Notes to budget as at 31 December 2023

- 1. Income from Membership fees for 2023 total of € 109,710 were received from all members with the exception of Spain (fee was paid in January 2024) and the Vernadsky National Library of Ukraine. The Board of Directors agreed in 2023 to suspend their fee due to the war.
- 2. Financial support AGM: € 10,959.71 were spent to cover the travel expenses of the following CENL members attending the 2023 AGM in Paris: Albania, Armenia, Azerbaijan, Bosnia-Herzegovina, Bulgaria, Croatia, Georgia, North Macedonia, Moldova, Montenegro, and Serbia.
- 3. Skills & Knowledge Exchange: bursaries & grants.

Skills & Knowledge Exchange bursaries, approved in 2023, all completed:

- Romania: Visit of the National Library of the Netherlands Total payment: € 1,000
- Latvia: Visit of the DNB in Leipzig to learn about the organisation of the Humanities and Natural Science Reading Rooms Total payment: € 941.74
- Serbia: Study visit of the National Library of Finland Total payment: € 1,000
- Moldova: Participation at "Let's Go green" Conference in Zagreb Total payment: € 929.19

Notes on Budget 2024:

Income:

Income comes mainly from the membership fees of 36 CENL members (checked until 2024-04-30). The annual membership fee for Ukraine has been suspended by the AGM 2023 due to the current situation.

*) Spain CENL fee 2023 was paid in 2024 (09.01.2024), Hungary CENL fee for 2024 was paid in in advance 2023 (20.12.2023).

Expenses:

Skills & Knowledge Exchange:

Three applications so far (Romania, visit to Biblioteca Nazionale Centrale di Firenze, Bosnia-Herzegovina, visit to National Library of Hungary, and Latvia, visit the Martynas Mazvydas National Library of Lithuania), upfront payments to Romania and Bosnia-Herzegovina each € 800 (Total € 1,600).

Hidden Stories fund:

The fund has been terminated by the Executive Committee. Final Payment Croatia $(2023) \notin 400$ was made in January 2024. Final Payment Greece $(2023) \notin 400$ was made in April 2024. Reminder that Hidden Stories Fund awarded to the British Library in 2022 (*BL youth take over "Through Young Eyes", led by local 13+ year olds introducing the Library, the building and resources, thereby exploring what the institution could mean to young people from underrepresented communities), has been postponed to 2024. The expenses of \notin 2,000 are expected to be covered by the end of 2024.*

Covid-19 support fund:

fund was terminated by the end of 2022.

CENL Network Groups:

1. Costs for BANG webinar 2023 € 3,582.08.

EKN grants:

In 2024, three EKN Grants were approved for Bulgaria, Georgia and Moldova. Bulgaria: "Cross-Border Collaboration for European Cultural Heritage Preservation and Sustainable Development of Library Services"



Georgia: Working conference with colleagues of the National Libraries of Georgia and Estonia with various activities Moldova: Study visit of 4 specialists from the National Library of Moldova to the National Library of Lithuania Bulgaria received an upfront payment of \notin 3,936.

Hungary received from their 2023 EKN Grant the final payment of \pounds 79.18.

Banking costs:

Banking costs consist of bank charges and bank transfer fees of € 262.14.

Audit & Legal costs:

the audit was once again done remotely for a cost of € 5,130.40 so far (final invoice will follow). The increased costs resulted from the general cost increase and adjustment at RSM.

Notes on proposed budget 2025:

Increase of € 5,000 for reserve (possible new funds as discussed at EC in Feb2024). Proposed total expenses for 2025 is now € 166,500.

Due to the increase in expenses, the income from the reserves also had to be increased by € 5,000.

With regard to the further use of the reserves, a constant reduction is aimed for over the coming years. This procedure was also considered as appropriate by the auditors.
